EU Foreign Policy and Hamas - Adeeb Ziaadeh

Shortly after the overwhelming victory of Hamas in the 2006 parliamentary and municipal elections, civil war broke out in the Gaza Strip between members of the two factions, Hamas and Fatah. The EU, along with the US, UN and Russia, not only gave its support to Fatah against Hamas, but also imposed a tough siege on the Hamas government in an attempt to force it to accept the Quartet's political conditions, described by Hamas leaders as unfair and impossible. Many observers are convinced that the EU's behaviour in this matter has been unreasonable and has conflicted with the EU's own democratic beliefs and values. This book sheds light on the EU's policies in Palestine mainly from 2003- 2013, and provides a thorough examination of the inconsistencies and paradoxes in the EU discourse towards Hamas, and the determinants underlying such contradictions. organization and discusses why the EU has boycotted its democratically elected body since 2006. Significantly, the book looks at whether the EU jeopardized its reputation and contravened its core normative values and objectives (democracy promotion, human rights, the rule of law and fundamental freedoms) by such a categorisation of Hamas. Exploring the EU's policy towards Hamas is vital for understanding how the relationship between the EU and the rest of the Islamists in the Middle East is perceived, as it enables both sides to have a cognitive basis upon which to construct better relations. This book, based upon a vast spread of primary EU documents and interviews, will therefore be a valuable resource for those studying the Arab Israeli conflict, Political Islamic movements, the Middle East Peace Process, and anyone with an interest in European Union Foreign Policy.

Considering both changes and continuities, this book examines how, why, and along which lines Egypt's external alignments under the al-Sisi regime emerged and developed. Egypt's foreign relations have changed substantially since the current regime took power in 2013. To assess this, the author develops and applies a unique analytical approach: the model of 'two-staged alignment formation.' In the first stage, domestic threats to the Egyptian regime's survival determined specific needs the regime tried to meet by approaching external partners. In the second stage, characteristics of the global and regional environments defined opportunities and constraints and therefore the regime's options and logical choices. In sum, the interplay of developments on the domestic, regional, and global levels resulted in a diversification of Egypt's external alignments, with China and Russia joining the EU and the US as Egypt's main global partners, and Saudi Arabia and the United Arab Emirates emerging as the regime's prime regional partners. Explaining the emerging alignment patterns from 2013 until 2017, this book aids understanding of the complexity of alignment formation and of Egyptian external relations in that critical period of time. This book will be of high interest to researchers and students working on Egyptian foreign relations, on relations between states, and on regional dynamics in the West Asia and North Africa (WANA) region. Mozambique's foreign policy towards South Africa - Paulo Mateus Wache 2022-07-20

This Book discusses the Mozambique's foreign policy framework in general, and towards South Africa, in particular, searching to understand

why it has been characterized by the hostility-friendship dichotomy. The Book argues that asymmetry alone cannot explain the occurrence of the dichotomy as suggested by Womack's asymmetry theory. In the case of Mozambique's foreign policy, the dichotomy is caused by combination of factors namely: power asymmetry, ideological differences, leadership perceptions, economic disagreements and economic ties. However, it is highlighted that power asymmetry is the main factor of the dichotomy. This complexity and amalgamations of causes of the dichotomy makes it a permanent and distinctive feature of Mozambique's foreign policy towards South Africa. Thus, the major contribution of this book is twofold. First, it presents a detailed and comprehensive analysis of Mozambique's foreign affairs as they have interacted with South Africa. Second, by applying asymmetry theory to Mozambique the study makes a significant theoretical contribution to understanding the agency of the smaller side in bilateral asymmetric relationships.

The Kurds and US Foreign Policy - Marianna Charountaki 2010-10-18

This book provides a detailed survey and analysis of US-Kurdish relations and their interaction with domestic, regional and global politics. Using the Kurdish issue to explore the nature of the engagement between international powers and weaker non-state entities, the author analyses the existence of an interactive US relationship with the Kurds of Iraq. Drawing on governmental archives and interviews with political figures both in Northern Iraq and the United States, the author places the case study within a broader International Relations context. The conceptual framework centres on the inter-relationships between actors (both state and non-state) and structures of material and ideational kinds, while the detailed survey and analysis of US-Kurdish relations, in their interaction with domestic, regional and global politics, forms the empirical core of the study. Stressing the intertwining of domestic and foreign policy as part of the same set of dynamics, the case study explains the emergence of the interactive and institutionalized US relationship with the Kurds of Iraq that has brought about the formation, within an Iraqi framework, of an undeclared US official Kurdish policy in the post-Saddam era.

Filling a gap in the literature on US-Kurdish relations as well as the broader topic of International Relations, this book will be of great interest to those in the areas of International Relations, Middle Eastern and Kurdish Politics.

Regional Institutions, Geopolitics and Economics in the Asia-Pacific - Steven B. Rothman 2017-04-21

This volume discusses the relationship between economics, geopolitics and regional institutional growth and development in the Asia-Pacific region. How do states (re)define their relationships amid the current global power transition? How do rival actors influence the rules and formation of new institutions for their own benefit? What role will institutions take as independent actors in influencing and constraining the behavior of states? Institutional development in Asia is characterized by idiosyncratic and diverse motivations (both material and non-material), a variety of policy strategies (strategic and norm-based), and the looming question of China's future depth of involvement as its economic position becomes more stable and its confidence in foreign affairs grows. This book focuses on the linking of the European Union Emissions Trading System (EU ETS) with other independent regional ETS. While rich

practical and academic research has evolved on the economic and technical side of ETS linking, political drivers and barriers have so far been underrepresented in this debate. Filling this lacuna and based on international relations theory, existing research and qualitative fieldwork, this book introduces the range of political conditions that influence linking, such as political leadership and stakeholder activity. This book concludes that FPA has to accept and give proper recognition to the judiciary and its

increasing relevance in foreign affairs.
