The Battles of King Arthur -

The ninth century *Historia Brittonum* is the first source that mentions Arthur and lists twelve battles, including the famous Badon Hill. Much ink has been spilt debating the identity and location of Arthur. This book will demonstrate that some of the battles can indeed be located with some confidence. Rather than fit a specific theory as to his identity the battles are placed in the fragmenting provincial, political and military context of the late fifth and early sixth century Britain. At a time of

rapid changes in cultural identity and a significant increase in Germanic material culture and migration. These battles might be expected to be found along borders and in zones of potential conflict. Yet this is not what is discovered. In addition the simplistic idea of Romano-Britons holding back invading Anglo-Saxons is found wanting. Instead we discover a far more nuanced political and cultural situation. One with increasing evidence of continuation of land use and the indigenous population. The most Romanised and urbanised regions of the south and east are the very areas that experienced the arrival of Germanic settlement. The conclusion gives the reader a new insight into what sort of man Arthur was and the nature of the battles he fought.

Roads in Roman Britain -

Hugh Davies 2002

In Roman Britain, the road between Londinium (London) and Novioforum (Chichester) was completed with an error of less than one degree, a feat it has often been assumed was

achieved without maps.

However, little is known of when, how, and even why they were built. Davies uses archaeological evidence to examine what was built, and places these findings in historical context using sources from antiquity. What makes this study unique however is his use of expert knowledge from his work as a professional highway engineer to understand the significance of the roads. Davies analyses the possible methods the Romans used in order to achieve the durability and accuracy for which they are renowned, maintaining the extensive network in a working state the quality of which would not again be paralleled until the 19th century.

The author starts with the pre-Roman origins of the network (many Roman roads being built over prehistoric routes) before describing how the Roman army built, developed, maintained and used it. Then, uniquely, he moves on to the post-Roman history of the roads. He shows how they were crucial to medieval military history (try to find a medieval battle that is not near one) and the governance of the realm, fixing the itinerary of the royal progresses. Their legacy is still clear in the building of 18th century military roads and even in the development of the modern road network. Why have some parts of the network remained in use throughout? The text is supported with clear maps and photographs. Most books on Roman roads are concerned with cataloguing or tracing them, or just dealing with aspects like surveying. This one makes them part of military landscape

archaeology.

**A History of the Post in
England from the Romans to
the Stuarts** - Philip Beale

From Roman times until this century the business of government has been largely carried out by the writing of letters, either in the form of instructions or of authorisations to deliver information orally. These documents were addressed to the recipient and authenticated by a seal or signature, often having a greeting and a personal conclusion. The

messengers who took them also carried copies of laws and regulations, summonses to courts and whatever else was needed for the administration of the country. Without a means of speedy delivery to all concerned there could be no effective government. Separate postal services developed to meet the needs of nobles, the church, merchants, towns and the public. This book discusses

three meanings of the word 'post': the letters, those who carried them, and the means of distribution. It shows that there is some continuity from Roman times and that the postal service established throughout England after the conquest of 1066 continued until 1635 when it was officially extended to the public, thus starting its amalgamation with the other services.
