He stated that, if this demand was met, he would "desist from terrorism". There was controversy as to whether the essay should be published, but Attorney General Janet Reno and FBI Director Louis Freeh recommended its publication out of concern for public safety and in hope that a reader could identify the author. Bob Guccione of *Penthouse* volunteered to publish it, but

Kaczynski replied that *Penthouse* was less "respectable" than the other publications. He said that he would "reserve the right to plant one (and only one) bomb intended to kill, after our manuscript has been published". The *New York Times* and *The Washington Post* both published the essay on September 19, 1995.

fraudulent manufacture of medicines is an old problem, vastly aggravated by modern manufacturing and trade. In the last decade, impotent antimicrobial drugs have compromised the treatment of many deadly diseases in poor countries. More recently, negligent production at a Massachusetts compounding pharmacy sickened hundreds of Americans. While the national drugs regulatory authority (hereafter, the regulatory authority) is responsible for the safety of a country's drug supply, no single country can entirely guarantee this today. The once common use of the term counterfeit to describe any drug that is not what it claims to be is at the heart of the argument. In a narrow, legal sense a counterfeit drug is one that infringes on a registered trademark. The lay meaning is much broader, including any drug made with intentional deceit. Some generic drug companies and civil society groups object to calling bad medicines counterfeit, seeing it

as the deliberate conflation of public health and intellectual property concerns. Countering the Problem of Falsified and Substandard Drugs accepts the narrow meaning of counterfeit, and, because the nuances of trademark infringement must be dealt with by courts, case by case, the report does not discuss the problem of counterfeit medicines.
